

TERMS AND CONDITIONS OF ENTRY FOR “THE GREAT OE” COMPETITION

1. ACCEPTANCE OF TERMS

- (a) Information produced by us on how to enter the competition draw and prizes for the competition draw forms part of these Terms. By entering the competition draw, you are deemed to accept these Terms. We reserve the right, in our sole discretion and at any time, to replace or amend these Terms or to modify, suspend, terminate or cancel the competition.

2. ELIGIBILITY

- (a) Except as set out at 2(b) and 2(c) below, the competition draw is open to NZ residents that are at least 18 years old.
- (b) You are not eligible to enter the competition draw if you are our employee, an employee of any company (including House of Travel or Mango/DDB) directly associated with the competition, or directly involved in providing a prize for the competition, or an immediate family member of such employees.
- (c) Acting reasonably, we may exclude any person from entering into the competition draw.

3. ENTRY

- (a) You may enter the competition by completing the Entry Form at any time between 9am on 10 December until 11:59pm on 12 January 2025 (“**Promotional Period**”). You can enter as many times as you like.
- (b) We cannot accept responsibility for any lost, misplaced, illegible, damaged, stolen, late or incomplete entries.
- (c) We reserve the right to extend or change the Promotional Period.

4. PRIZES

- (a) After the Promotional Period, all eligible entries will be judged by a panel from the Auckland Airport corporate services team and the winning entries will receive a \$500 Prezzy Card (up to four Prezzy cards up for grabs) and the Prezzy card winner will win go into a draw to win the **Main Prize** of a \$10,000 travel voucher (see conditions below)
- (b) Photos will be displayed around the Airport and the entrants will win one \$500 Prezzy card each.

(“Prizes”)

- (c) Conditions that apply to the Prizes are:

- (iv) The Prize is taken entirely at the prize winner's own risk. We will not be liable for any loss, damage or injury (including but not limited to any indirect or consequential loss) suffered or incurred by you or any other person as a result of or in connection with the competition or any prize, except for any liability which cannot be excluded by law.
- (v) We may amend or modify these Terms and Conditions at any time.
- (vi) These Terms and Conditions are governed by New Zealand law and any dispute arising out of or in connection with them will be subject to the exclusive jurisdiction of the New Zealand courts.

5. WINNING

- (a) The Prize winner will be determined by judge's decision. The judging will take place **13 January – 17 January 2025**. Only the person who originally entered the competition is eligible to win a Prize.
- (b) We will notify the Prize winner[s] by email and/ or phone call, provided when they entered.
- (c) If a Prize winner fails to claim the Prize within seven days following notification, the Prize will be forfeited. In those circumstances, we reserve the right to offer the prize to another entrant or in a future competition.
- (d) We may, at any time, verify the validity of a person that has entered the competition draw (including a person's identity, age and place of residence).
- (e) We may refuse to award the Prize to any person who has, in our view, acted in a fraudulent manner, breached these Terms or gained an unfair advantage in participating in the competition.

6. DEFINED TERMS AND INTERPRETATION

In these Terms, the following words have the following special meanings:

"**Terms**" means these competition terms and conditions (as amended from time to time);

"**we**", "**our**", "**us**" means Auckland International Airport Limited; and

"**you**" means a person entering the competition.
